## #Brexit Ready



As you all know at this stage the UK may still leave Europe without a trade deal, and we here at Trimfold Envelopes have taken a worst case scenario approach to this.

All our raw materials come in from the Euro Zone countries and local suppliers, so we do not envisage interruption to our supply chain.

We also have installed 2 more machines for manufacturing large pockets, we have bought these products in the past from our sister companies in the UK, we thought it prudent to do this given the uncertainty of Brexit. We now have 6 high speed envelope manufacturing machines with up to 5 colours flexographic, 7 lithographic envelope overprinting printing machines (2 and 4 colour machines), 2 high speed laser envelope printing machines and one ink jet line for printing carrier bags, bubble bags, numbering and variable data. We have also added to our overprinting capacity with the installation of a high-speed ink jet machine for envelopes (32,000 envelopes per hour full colour).

For our Northern Ireland and mainland UK customers, we have set up Trimfold Envelopes NI, trading out of Northern Ireland and this gives customers the option to order through NI or ROI, depending on what suits best.

I hope this clarification on how Trimfold Envelopes is Brexit ready will give you continued confidence that we will be able to meet any requirements you may have.

We look forward to your continued support in 2021.

In preparation for Brexit and to ensure a smooth transition in January we are investigating the various requirements both for ourselves and for our customers/suppliers.

*“Customs procedures will come into force on the 1<sup>st</sup> of January 2021 for all shipments in and out of the UK, regardless of current negotiations which are purely about tariffs”*

The following will be required for each shipment:

**Full Packing list.** – (Delivery Note) requiring some additional information.

Details of all the products being shipped including their commodity / Taric Codes  
Trimfold EORI Number (**IE64309540**) and Company VAT Number (**IE64309540**)

If you have not already done so, agree the terms of shipment with your customers and suppliers i.e. who is paying for what charges incurred in the delivery, custom clearance fees, delivery charges etc *Please see Inco Terms below.*

You will need to find out with your Customer and Supplier if they have engaged with an Agent on the other side as there will be two clearances required with each shipment. Tariffs if applicable are separate to vat charged at point of entry.

Please be aware that should UK leave the EU without a deal, all Wood Packaging Material (WPM)- including pallets – entering or leaving the UK will need to be **heat-treated in accordance with ISPM15 International standards**, and may be subject to official checks either upon or after entry to the EU.
