We have an onsite internal PEFC and FSC auditor to manage the implementation of our FSC and PEFC systems and we also employ an external audit consultant who attends Trimfold Envelopes Limited regularly to carry out spot check internal audits and to keep our staff updated and aware of all FSC and PEFC regulations.

All paper used by Trimfold Envelopes Limited is sourced from environmentally responsible sources and all product supplied by Trimfold Envelopes Limited complies with the relevant environmental paper standards and as mentioned above is FSC and PEFC accredited. We do not engage in spot buying paper from questionable environmentally damaging sources, such paper is available on the market at cheaper prices but as well as the environmental concerns such paper would raise, the variation in paper quality can lead to problems with consistent running on mailing machines and colour variation in white grades which in turn could damage Trimfold Envelopes Limited's reputation for supplying high quality product.

All of our inks and glues used in manufacture are 100% water-based products and we only purchase such materials from reputable ink and glue suppliers. Our flexographic plate making systems are also water based and environmentally safe.

We are very proud of our PEFC and FSC accreditations and plan on continually improving our standards to maintain our certification. As a company we believe the environment and particularly forestry and paper sustainability is extremely important and we are continually reviewing our suppliers and paper mills to ensure we are working with companies that are of the highest standard with regards to environmental protection and maintaining an ecological balance.
