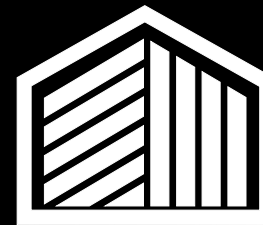

If the company is providing replacement materials, it may elect to replace the percentage listed below, if refunding the purchase price, it may elect to refund the percentage as listed below.

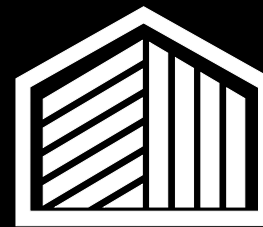

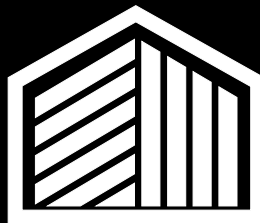
